COVID-19 Stakeholder Update

- We have robust and flexible plans to ensure we can continue to deliver key services across the justice system.
- [Independent public health monitoring](#) suggests the steps we have taken are successfully limiting deaths and the transmission of coronavirus in prisons. These actions helped to create space allowing jails to implement 'compartmentalisation', meaning staff have isolated those prisoners with symptoms, shielded the vulnerable and quarantined new arrivals. Consideration can now be given to [how these restrictions can be cautiously rolled back](#) over the coming weeks and months.
- We're focussed on maximising our capacity to reduce the growth and volume of our outstanding work. We are working closely with the judiciary to further expand remote audio and video hearings; and ensuring that we can reopen our estate for more face to face hearings as soon as it is safe to do so.

NEW: Criminal Legal Aid Review Accelerated Areas consultation to close on 17 June. Following close engagement with the criminal legal aid profession, and due to the exceptional circumstances presented by the Covid-19 pandemic, the Ministry of Justice communicated on 27 March the decision to extend the consultation until further notice. After consultation with the sector, we will now be closing the consultation on 17 June. The government will respond in due course. HMPPS

Prisons and probation services have implemented significant changes to comply with the Government's social distancing rules and to protect staff and service users. The service has been working closely with public health experts, as well as criminal justice partners, to ensure that robust contingency plans are in place and immediate action can be taken wherever cases are identified. As of 17:00 on TUESDAY 9 June:

- 490 prisoners have tested positive for COVID-19 across 80 prisons;
- 961 prison staff have tested positive for COVID-19 across 105 prisons;
- 26 Prisoner Escort and Custody Services (PECS) staff have tested positive for COVID-19.

These figures reflect the total number of recorded positive cases – not the number of live cases – of COVID-19, and includes individuals that have recovered. Figures are interim and are subject to revision as more information becomes available.
