We have robust and flexible plans to ensure we can continue to deliver key services across the justice system.

- This week we are planning to reopen a further 40 courts for face-to-face hearings, on top of the 16 <u>announced</u> last week. Court staff have been working tirelessly to facilitate this in order to guarantee the delivery of justice, protecting the public, and continuing on the careful path to recovery.

#### **HMCTS**

During this unprecedented public health emergency, we are adjusting practices and taking steps to minimise the risk to the judiciary, court staff and users. Any changes to individual hearings will be communicated directly to those affected in the usual way, by email and/or phone. ## **HMPPS**

Prisons and probation services have implemented significant changes to comply with the Government's social distancing rules and to protect staff and service users. The service has been working closely with public health experts, as well as criminal justice partners, to ensure that robust contingency plans are in place and immediate action can be taken wherever cases are identified. As of 17:00 on WEDNESDAY 17 June:

- 503 prisoners have tested positive for COVID-19 across 81 prisons;
- 980 prison staff have tested positive for COVID-19 across 105 prisons;

• 27 Prisoner Escort and Custody Services (PECS) staff have tested positive for COVID-19.

These figures reflect the total number of recorded positive cases – not the number of live cases – of COVID-19, and includes individuals that have recovered. Figures are interim and are subject to revision as more information becomes available.
